SCALABILITY SOLUTIONS



BLASTAR'S TAX SYSTEM IS DESIGNED FOR SUSTAINABILITY AND COMMUNITY BENEFITS:

BUY TAX:

0% ON BUYS

BLASTAR IMPOSES NO TAX ON PURCHASES, ENCOURAGING USER ADOPTION AND PARTICIPATION.

SELL TAX: 30% ON SELLS



BLASTAR IMPOSES A 30% TAX ON SELLS, WITH THE DISTRIBUTION AS FOLLOWS:

25% TO REDISTRIBUTION:

DISTRIBUTED PROPORTIONALLY TO HOLDERS BASED ON THEIR TOKEN HOLDINGS.

5% FOR DEVELOPMENT AND MARKETING:

ALLOCATED TO FUND FUTURE DEVELOPMENTS AND MARKETING CAMPAIGNS.

TOKEN DISTRIBUTION

HOLDER DISTRIBUTION:

86.44% IN THE HANDS OF HOLDERS.

DIVIDENDS AND REWARDS

THE 25% REDISTRIBUTION POOL IS DISTRIBUTED DIRECTLY PROPORTIONAL TO TOKEN HOLDINGS.

DIVIDENDS ARE RECEIVED IN PULSECHAIN'S NATIVE TOKEN, \$PLS.

EXAMPLE:



IF A USER SELLS \$1000 WORTH OF \$BLAST, 30% GOES TO THE DIVIDENDS POOL.

OF THE \$300:

250 \$PLS GOES TO HOLDERS, DISTRIBUTED BASED ON THEIR HOLDINGS. 50 \$PLS IS ALLOCATED FOR DEVELOPMENT AND MARKETING.
